II. Basic principles of personal data processing

1. We approach the processing of your personal data professionally, sensitively and in compliance with all obligations imposed on us by law.
2. We only obtain from you the data that is necessary to fulfill the purpose on the basis of which you contacted us.
3. You can ask us at any time to immediately delete your personal data, as well as the history of our communication via e-mail, SMS messages or social networks.
4. We always provide information on the processing of personal data to the client before the agreement on the provision of our services. It is available on the website www.healthandtraining.org

III. Purpose, scope and duration of personal data processing

1. We process your personal data for the following purposes:
 - a. Agreement or Contract on the provision of services and their implementation - the processing of personal data is necessary for the provision of offered services and the communication with the client.
 - b. Marketing - sending newsletters.
 - c. Accounting - the processing of personal data is necessary for this purpose due to the fact that their processing is required by law. These are mainly the following regulations: Act no. 431/2002 Coll. of laws on accounting. The Operator processes personal data for this purpose to the extent specified by the relevant legal regulation.
2. We process your personal data in an effort to limit its scope to the minimum necessary, which includes:
 - a. Identification data, in particular name, surname, title, date of birth, age, occupation, sport, gender and signature.
 - b. Contact details of the Client, especially contact addresses, e-mail addresses and telephone numbers.
 - c. Information from social networks, which the client publishes himself, can be used to implement our marketing activities.
 - d. Information from surveys that we use to know the client's opinion on existing products and ads, or if we want to find out what services the client is interested in.
3. We process and store your personal data during the period of service provision and subsequently for a maximum of 3 months from the termination of the agreement on the provision of services for advertising and marketing purposes. After this period, your personal data will be securely and permanently deleted from our database.

IV. Terms of personal data processing

1. The operator has taken appropriate technical, organizational and personnel measures that will lead to a high level of protection and security of clients' personal data.
2. The Operator undertakes to treat and handle the personal data of the data subject in accordance with the valid legal regulations of the Slovak Republic and EU regulations.

V. Rights of the persons concerned

1. The right of access to personal data - the client is entitled to request the Operator for access to his personal data, he is also entitled to request information on the processing of his personal data.
2. The right to correct personal data - the client is entitled to object to the incorrect or unauthorized processing of personal data and is entitled to request the correction or addition of such personal data.
3. Rights in case of breach of obligations stipulated by the law on personal data protection - the client is entitled, in case of breach of obligations of the Operator concerning the collection or processing of his personal data, to ask the Operator to provide an explanation of such proceedings, refrain from such proceedings, to remedy the situation thus created or to provide, at his own expense, an excuse or other satisfaction for the personal data to be blocked or destroyed.
